- 9. You must visit the fair and collect customized stamps from the "Buying Mission Service Counter" in order to qualify for the incentive. **Only 1 stamp can be collected on each fair day.**
- 10. The original copy of acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the reimbursement collection. HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
- 11. HKTDC reserves the rights to vary the terms and conditions, change or terminate the sponsorship programme without any prior notice. In case of any dispute over the programme, the decision of HKTDC shall be final and binding.
